## TSCe Information

### Battery safety

The battery is NiMH 18.5 watt hours 4.8V.

- Do not disassemble, mutilate, or puncture the battery pack. A battery can burst or explode, releasing hazardous chemicals. There are no serviceable parts inside. Do not expose to temperatures above 60°C (140°F).
